The name and address details that appear on your current registered holding **must be an exact match** with the registration details on your Trading Account. If your details differ, you will need to contact your existing sponsoring participant (broker) to change your registration details, or authorise us to make the changes by nominating below so we can process this transfer without delay or rejection. Please also ensure that you have no outstanding orders or pending trade settlements for the investments you wish to transfer.

Broker Sponsored Holdings If your shares are Broker Sponsored, you will have a Holder Identification Number (HIN) allocated to your holding rather than a Securityholder Reference Number (SRN), which starts with an 'X'. You can be sponsored on CHES by more than one broker or institution and you can even maintain holdings in the same security under different sponsorships.

Holder Identification Number (HIN) is a unique number that you are issued when you are CHES/Broker Sponsored Holder. Your HIN can register multiple securities under the one HIN. A HIN starts with the letter X and is followed by ten numbers e.g. 0002468123.

PID is an acronym for Participant Identification Number. This is the Broker's identification number. Our PID is 6381.

Related Definitions

CHES stands for Clearing House Electronic Sub-register System. The CHES Settlement Facility is a computerised share registry and settlement system operated by the ASX Settlement Corporation, a subsidiary of the ASX. CHES records an account's share ownership via the ASX's computer-based share and settlement transaction system. An account's security holdings are recorded against their HIN and a statement is sent out to their registered address.

Securityholder Reference Number (SRN) is a unique number that identifies you as an Issuer Sponsored holder with a listed company. A SRN usually starts with the letter 'I' e.g. I00012345678. If you hold shares in more than one company and choose to be Issuer Sponsored, you will have a different SRN for each shareholding.
